I am always amazed at how fast a year goes by. We began the year anticipating the opening of the new Rainbow Recycling facility. We had the grand opening in September and with the new facility we now have the ability to greatly increase the amount of material we process. It has been exciting to see this new facility open and serve an increasing demand in the community.

We continue to provide services to individuals in our residential and vocational programs. It is very rewarding to see their growth of learning new skills, working together in



teams and meeting goals. As with all of us, having employment is good and knowing that you are being productive and receiving a paycheck is very important. We are thrilled that these types of services can be offered.

A new expansion of our services began in the spring. We were notified about the agency providing early childhood intervention services in Artesia, NM was going to close at the end of June. Since CARC is already a provider of those services in Eddy County, we made the decision to open an office in Artesia for our Child Development Services. As we anticipated a transfer of children from the closing program, the new staff in Artesia quickly got up to speed on this new service for that community and the numbers of children being served began to grow.

We believe there is a big need for early intervention services in Artesia and we are proud to be able to bring our expertise to that community.

As always, we are grateful to everyone who helps support our programs and services. Without the gracious donations we receive, it would be very difficult to upgrade and grow our services. To all of you I say Thank You!



CARF Accreditation

CARC underwent CARF reaccreditation process this fiscal year. We are proud to report that we have been awarded our seventh consecutive CARF Three-Year Accreditation in the following programs:

- Child and Youth Services
- Community Employment Services: Employment Services
- Community Employment Services: Job Development
- Community Housing
- Community Integration
- Organizational Employment Services
- Respite Services
- Service Coordination
- Supported Living





This accreditation represents the highest level of accreditation that

can be awarded to an organization and shows the organization's substantial conformance to the standards established by CARF. An organization receiving a Three-Year Accreditation has put itself through a rigorous peer review process and has demonstrated to a team of surveyors during an onsite visit that its programs and services are of the highest quality, measurable and accountable.

CARF is an independent non-profit accrediting body whose mission is to promote the quality, value and optimal outcomes of services through a consultative accreditation process that centers on enhancing the lives of the persons served. Founded in 1966 as the Commission on Accreditation of Rehabilitation Facilities, the accrediting body established consumer-focused standards to help organizations measure and improve the quality of their programs and services.

Some of the comments from the CARF surveyors include:

Organizational Highlights

Support Services

This fiscal year, CARC provided Staff Nursing and Case Management services to 108 individuals. These services include development of individual plans focused on meaningful day activities, skill enhancement, and support needs. Service coordination is designed around each individual's personalized vision and goals. Support services collaborate with other agencies and community organizations to assist individuals where needs are identified. In addition, Respite services were provided to fifteen of these adults in a variety of settings.

Residential Programs


The objective of the Residential Services Program is to provide individualized services that maximize dignity, respect and independence; encourage individuals to strive for their fullest potential; and help fulfill each individual's definition of what is meaningful to them. This program is designed around each individual's personal needs that provide supports to learn and/or retain skills necessary to live as independently as possible. The residential program offers varying support levels to achieve this objective. Our Supported Living and ICF/MR homes offer 24-hour care to provide continued support for an individuals daily living needs. Our Independent Living services offer varying levels of care, from intensive support to minimal assistance, based on personal support needs. In residential settings, individuals learn skills associated with meal preparation, cleaning, grocery shopping, banking, and other basic daily life skills. In addition, individual plans encourage further development in health and safety, community independence, leisure time management, and other skills that foster independence and improve quality of life. At the end of the fiscal year, 69 individuals were receiving services through our various levels of residential options.

Supported Employment

The Supported Employment program assists individuals in finding and retaining jobs in community settings. This may include contracted job, job carving, and individual placements. Vocational strengths, needs, interests, and preferences are used to find employment opportunities best suited for each individual. Job coaching is provided at an individual level and adjusted as needs change. At the end of the fiscal year, 24 individuals were receiving supports from this program.

Community Inclusion

The Community Inclusion Department consists of the Life Enhancement, Community Inclusion and the Activities programs. Life Enhancement and Community Inclusion provide individuals with various enriching activities including volunteer work,







around each individual's meaningful day definition, as well as sensory, physical and health needs. At the end of the fiscal year, fifteen individuals were receiving supports through Life Enhancement and Community Inclusion programs. The Activities program provides recreational periods for individuals in the evenings and on weekends, as well as participation in local events. Recreational activities include social gatherings, crafts, various recreational sports, and participation with our local Special Olympics program.

Work Services

CARC's Work Services program continues to provide employment opportunities and training in a structured work environment to aid in the development of various vocational skills. By offering affirmative employment options, individuals who may not otherwise have an opportunity for employment are able to earn a paycheck.

CARC offers affirmative employment options in a variety of settings to allow for various options for skill development and employment opportunities. This program assists with development of skills needed to obtain community employment.

• Grounds/Janitorial

Eleven individuals were working in the Grounds/Janitorial department at the end of the fiscal year. Each individual has specific program outcomes to develop and strengthen their general job skills and skills related to general housekeeping and lawn care. By improving these skills, individuals have a better chance of obtaining community employment.

• Dining Hall

The CARC Dining Hall was employing nine individuals at the close of the fiscal year. These individuals assist in the preparation of lunch for the various CARC worksites, serving, and clean-up duties as related to meal service. These job duties help teach skills that can be used both at home and for job opportunities in the community.

• Rainbow Recycling and Secure Document Destruction Services

CARC's recycling continues to grow. Thanks to the support of Eddy County and the City of Carlsbad, CARC was able to expand recycling operations with a new facility to process recyclables. This has not only allowed us to expand our recycling efforts in the community, but has allowed us to increase our Document Destruction services and provide more job opportunities for the individuals we serve and for the community. The new facility now provides equipment to allow for faster sorting of collected materials, while our old recycling center has been dedicated to our shredding contracts and sorting of recyclables that are collected at the on-site drop off containers. This fiscal year 761.45 tons of recyclables were diverted from the landfill, an increase of nearly 62% over last fiscal year's weight of 471 tons! As of the end of the fiscal year, thirteen individuals were employed at Secure Document Destruction Services and two individuals were employed at Rainbow Recycling.

• Country Store and Greenhouses

The Country Store and Greenhouse offers a wide variety of plants year-round for community purchase. Plants are grown and maintained in our greenhouses by individuals served. Plant Rentals - an extension of the Country Store - continues to offer maintained planters to various locations around town. The individuals working in these departments get the opportunity to learn various horticulture skills. 28 individuals were working in the Potting Barn, Country Store and Plant Rentals at the end of the fiscal year.

• Pecos Valley Pecans

Pecos Valley Pecans offers quality pecans for retail. Our pecans are known for their throughout the state. The Grounds department harvest pecans from our orchards and individuals working at Pecos Valley Pecans shell and clean them. Thirteen individuals were employed in the pecan processing plant at the end of the fiscal year.

Child Development Center

• Rainbow Connection Childcare

The Rainbow Connection Childcare center offers childcare services to both typically developing children and those who are at risk or have been identified as having a developmental delay. The center provides childcare services between the ages of six weeks to 30 months. We continue to be a preferred A total of 48 children were provided services through the childcare center this fiscal year.

• Parent Self-Monitoring Screening Program

The Parent Self-Monitoring Screening program assists parents in tracking their child's development to age five. At the close of the fiscal year 206 children were enrolled in the program. This program is a free service that allows parents to review and monitor their child's early developmental stages. Results from these evaluations may include referrals to local services to further support the child's development if delays/concerns are noted.

• Early Intervention Program

The Early Intervention Program goal is for young children to increase developmental abilities in an effort to decrease the need for special developmental programs when entering school. Services are provided to children birth to age three who have developmental delays, established conditions or are identified as at risk medically

or environmentally. Services are tailored to meet the specific needs of the child and family and include services such as speech, physical and occupational therapy services when need is identified. There is no charge to the family for these services. This fiscal year 423 children were provided early intervention services. 67% of the children served this fiscal year maintained or decreased their developmental delays based on developmental assessments and evaluations based on developmental skills for their age.

Outcomes

CARC strives for excellence in all service areas. Satisfaction questionnaires reflect the following results:

- 95% feel that their individual progress plan is helping them move toward their personal vision.
- 95% of individuals in Work Services programs rated overall services at "good" or "excellent".
- 94% of individuals in the Residential program rated overall services at "good" or "excellent".
- 100% of individuals in the Supported Employment rated overall services at "good" or "excellent".
- 91% of individuals in the Community Inclusion program rated overall services at "good" or "excellent".
- 98% of families are satisfied with the services provided through the Early Intervention program.

Improvements

This year we were able to make several improvements as part of our accessibility and strategic planning process. These projects included:

- Renovations to the Pritchett pool
- New flooring in bedrooms and dining/kitchen areas of all our group homes
- Fresh coat of paint throughout all of our group homes
- New furniture for several of our group homes
- New accounting and personnel software
- Implementation of electronic documentation through Caretracker system using iPads in all service areas
- Replacement of two vans and two trucks to maintain our fleet of vehicles to meet client and business needs

Camp Washington Ranch

Camp Washington Ranch offers a wide variety of accommodations and services for any event. The camp is centrally located near Carlsbad Caverns, Guadalupe Mountains National Park, the Pecos River, Living Desert State Park, and surrounded with numerous natural caves and trails. Since inception in 1991, the Bargain Store has raised \$2 million dollars that has been used to directly benefit the individuals we serve.
